

## **FACILITATION NOTICE - SKILLED MIGRATION VISAS**

This information is only for holders of one of the following visas

- Distinguished Talent (subclass 124)
- Distinguished Talent (subclass 858)
- Global Talent (subclass 858)

THIS OFFICE WILL NOT RESPOND TO FACILITATION REQUESTS FOR OTHER VISA SUBCLASSES.

PLEASE DIRECT YOUR ENQUIRY TO THE DEPARTMENTAL OFFICE THAT GRANTED THE VISA.

If you were outside Australia when you were granted one of the above visas then your visa grant is subject to visa Condition 8504 which provides that:

The holder must enter Australia as the holder of the visa to which the condition applies before a date specified by the Minister.

This condition requires that each visa holder must make their first entry into Australia before the "For first entry, arrive by" date specified in the "Grant Notification" letter.

Skilled Migration is aware that in certain circumstances you and/or family members who were granted a visa as part of your application may not be able to comply with this condition.

Failure to comply with visa conditions can render a visa liable for cancellation under the Migration Act 1958 and visa holders are strongly encouraged to make their first entry to Australia by the initial entry date provided in your grant notification, however, generally we will not seek to cancel a skilled visa where the only reason for doing so would be breach of this condition.

## Visa Validity Period

If you are not able to make your first entry into Australia before the "For first entry, arrive by" date you can use this Notice when you travel to Australia during the validity period of your visa. Information about your visa validity period is specified in the "Grant Notification" letter, as the "Must not arrive after date". Generally, visa holders will be permitted to make their first entry into Australia at any time before the "Must not arrive after" date.

We cannot extend the validity period of your visa, and if your Skilled visa ceases for any reason then you cannot use this notice to enter Australia as the holder of this visa.

## **Travelling to Australia**

You should carry a copy of this notice when travelling. You may need to show it to your travel provider or the airline when checking in at the airport, and to the border officer on arrival in Australia.

This notice should be sufficient evidence for a travel provider to be satisfied that the visa holder can enter Australia as the holder of a Skilled Migration visa. If you show this letter to the airline, but still have a problem checking-in for your flight, ask the airline representative to contact the Australian Border Operations Centre (BOC) to resolve the issue.

You can only enter Australia while the visa mentioned above is valid. Information about your visa validity period is contained in your visa grant notification. You can check your visa details in VEVO: <a href="https://www.homeaffairs.gov.au/vevo">www.homeaffairs.gov.au/vevo</a>

## Children born outside of Australia
